WHATCOM CONSERVATION DISTRICT Public Meeting Minutes March 12, 2015

I. Time and Place of Meeting.

A regular meeting of the Board of Supervisors of the Whatcom Conservation District (WCD) was held at the Ag Service Center, 6975 Hannegan Rd, Lynden, Washington on March 12, 2015, at 7:00 p.m.

III. Meeting Called to Order.

Joe Heller, Chair, called the meeting to order at 6:55 p.m.

IV. Public Comment (written or in person).

There were no public comments.

V. Alex Hall, Natural Resources Conservation Service (NRCS).

Environmental Quality Incentives Program (EQIP) -

NRCS staff ranked 50+ applications. Alex reported that the funds have not been allocated yet. He anticipates about \$400,000 for EQIP across the NW team.

National Water Quality Initiative (NWQI) -

The National Water Quality Initiative program signup ends on April 15, 2015. This initiative has \$2.5 million allocated.

Conservation Stewardship Program (CSP) -

The renewal letters went out to all current contracts. There is only one in Whatcom County. There are no new signups for this program this year.

NRCS office -

NRCS has moved out of the front office space. Joy Hawley maintains a NRCS staff presence in the FSA office in Lynden until the federal offices are able to move.

VI. Approval of Minutes of Previous Meeting.

Larry Helm moved that the minutes of the February 12 & 20, 2014 Board meetings be approved as mailed. Dick Yoder seconded the motion. The motion passed.

VII. Financial Report.

VIII.Action Items.

A. Approval of Conservation Plans.

Small Acreage Livestock Farm Plan Approval -

Corina Cheever completed an inventory and farm plan for Atwood Ales (Smith). It fulfills the requisite elements for that type of plan. Staff recommended Board approval.

Larry Helm moved to approve the moderate intensity farm plan for:

• Atwood Ales (Stephen, Leslee and Josh Smith).

Larry Davis seconded the motion. The motion passed.

Whatcom County PIC Cost-share -

Corina Cheever completed an inventory and farm plan for Glenn and Mary Alden. It fulfills the requisite elements for that type of plan. Staff recommended Board approval. Glenn and Mary Alden are seeking cost-share through the County PIC cost-share program.

Larry Davis moved to approve the standard checklist farm plan for Glenn and Mary Alden and approve their Whatcom County PIC cost-share application for 75% of expenses not to exceed \$3,000 for costs incurred after the execution of the cost-share agreement. Larry Helm seconded the motion. The motion passed.

EPA – Birch Bay Project Cost-share –

Three landowners submitted a cost-share application for septic system inspection as a part of the EPA Birch Bay project pursuant to adopted cost-share policy previously adopted by the Board.

Larry Helm moved to approve the EPA Birch Bay Cost-share application for septic tank inspection fee of \$100:

Larry Davis seconded the motion. The motion passed.

B. Employee Matters.

<u>District Employee Step Increase</u> -

When negotiating with Aneka Sweeney over her beginning salary, it was settled upon Band C1 Step 4 as a starting point with a provision to review her performance after 6 months. Aneka Sweeney is eligible for a step increase effective March 1, 2015.

Larry Helm moved that for good cause shown, the Board advances Aneka Sweeney to Band C1 Step 5 effective March 1, 2015. Dick Yoder seconded the motion. The motion passed.

C. Cash Registers.

The District has rented cash registered for many years. We were informed by our supplier that they would not be able to do this in the future. Dawn checked with other Districts and they have encountered similar issues when renting cash registers. It is necessary to be able to track transactions and provide a receipt for sale customers. Staff recommended that the Board purchase 4 cash registers.

Dick Yoder moved to purchase 4 Sharp cash registers for \$1,300 plus tax from Bellingham Business Machines. Larry Davis seconded the motion. The motion passed.

D. Columbia School Donation.

Aneka Sweeney was contacted by two members of the Columbia Elementary School Parent Teacher Organization; they are on the School Grounds Committee. They contacted the District in hopes of creating a partnership to help with education, planning and planting of a portion of land by the school. Columbia School is seeking District staff time for education and the donation of plant materials to the project.

Larry Helm moved to approve the Columbia Elementary School Native Plant Garden Project supplying staff time for education and some plant materials. Dick Yoder seconded the motion. The motion passed.

The Whatcom Conservation District's Native Plant sale is scheduled for Saturday, March 28, 2015.
